Painted Steel Coil Lifetime Warranty Non-Prorated & Transferrable

Custom-Bilt Metals (herein referred to as CBM) warrants to the original owner(s) of all CBM painted steel coil products that CBM warrants all painted steel coil to be free from painting defects. This warranty is effective from the date of original installation and will remain in effect as long as the original owner(s) is alive. In the event of more than one original owner(s) - (husband and wife) the warranty will remain effective as long as one of the original owners remains alive. This Non-Prorated, Lifetime Limited Warranty is transferable by the original purchaser(s) to subsequent owner(s). When and if the warranty is transferred, the warranty period will be for a term of forty (40) years from the date of installation.

If the original purchaser is someone other than an individual, such as a government agency or entity, corporation, church, school, etc., the warranty will extend for a period of 40 years.

Parameters of Coverage

CBM's painted steel coil is manufactured from the finest products available. We use the finest paints and application processes available. CBM warrants that its paint will not crack, chip or peel. All of the above named items are subject to the following terms and conditions: This warranty covers only flaking, chipping, and peeling. No other warranty is expressed or implied.

Coverage Exclusions and Limitations

The above mentioned warranty does not cover damage to the coil or paint due to the following conditions: improper installations of products, settlement of structure, accidental damage, structural shrinkage or distortion of structure, vandalism, hail, fire, tornado, windstorm, earthquakes, lightning; fumes or vapors, acts of God, misuse or abuse of the products, mildew accumulation, moss, impact of foreign objects, normal weathering, caustic atmospheric conditions, lack of proper cleaning (must be cleaned once a year) or any other causes that are beyond the control of CBM.

If during the warranty period the CBM painted steel coil fails to perform in accordance with the above stated standards, CBM will upon notification and validation of the complaint by physical inspection, either repair, replace or refinish, at its option, the defective products, without charge to the original property owner(s).

CBM maintains the right to discontinue or change any of it's products. If the products covered by this warranty are not available at

the time of claim CBM at it's sole discretion will retain the right to substitute a product of similar or greater quality or value.

CBM's obligation under this warranty shall at no time exceed the original purchase price of this product at time of installation. Any cost that may exceed CBM's liability shall be borne by the owner.

If it is determined by CBM that the product cannot be repaired or refinished after a reasonable number of attempts CBM will provide a refund.

CBM is giving the purchaser an express lifetime limited warranty under the provisions of the Magnuson-Moss Federal Warranty Act. CBM cannot and will not be liable to you or any subsequent owner(s) for a breach of any written or oral express warranties, such as those given you by a CBM dealer, franchisee, or applicator of any CBM painted steel coil product. ANY IMPLIED WARRANTIES IMPOSED BY LAW, SUCH AS THE IMPLIED WARRANTIES OF MERCHÁNTABILITY AND FITNESS FOR A PARTICULAR PURPOSE ARE LIMITED IN TIME TO THE DURATION OF THIS EXPRESS WARRANTY. CBM SHALL NOT BE LIABLE FOR ANY CONSEQUENTIAL DAMAGES for breach of any express, written, oral, or implied warranty on any painted steel product. Your EXCLUSIVE REMEDY shall be repair, replacement or refinishing solely at CBM's option, only on terms stated in the certificate. SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES AND SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATIONS OR EXCLUSIONS MAY NOT APPLY TO YOU.

This warranty gives you certain legal rights. Other legal rights may vary from state to state.

This warranty covers only CBM's painted steel coil

CBM reserves the right to withdraw this warranty from the market at any time. Any and all warranties in effect at the time of removal will not be affected by the withdrawl, and will remain in affect until their expiration.

Registration of Warranty

This warranty becomes effective when the CBM installer and the owner complete this warranty application. Upon completion of this application it will be mailed to the nearest CBM branch office within 30 days after the installation is complete. Failure to do so will render this warranty null and void.

Transfer of Warranty

This warranty is transferable by the original purchaser(s) to subsequent owner(s) of the property provided that CBM receives written notice of the transfer within 30 days of the property title transfer. The transfer of the warranty will cause the warranty to revert to a 40 year non-prorated warranty effective from the date of original installation. Failure to notify CBM in writing within 30 days of transfer will relieve CBM of any future obligation as stated.

Any claim made hereunder must be presented to CBM within the warranty within a reasonable period of time after discovering the defect.
